It is anticipated that it will change with input through community engagement. Once the outline is more finalized, members of the County's Climate Change Task Force will begin to draft the chapters, which will also be informed by input from the community and coordinated with County departments.*

#### **Commercial Energy Conservation and Renewable Energy – Supply, Distribution, and Buildings**

- Decarbonizing the power sector by ramping up renewables and moving away from fossil fuel
  - Large scale renewables
  - Distributed renewables (e.g., rooftop and community solar)
  - Siting, community benefits, and ownership
- Clean heating, cooling and building electrification
- Battery technology and storage

- Public power (public ownership and control of local/regional generation/distribution systems) – community solar, microgrids

### **Transportation**

- Implement Transportation policies that reduce single-occupancy vehicles (e.g., road diets) and make our public transit system more attractive, accessible and beneficial to those with and without private vehicles.
  - Complete streets (Accessibility, Pedestrians, Bicycling, Connection to Public Transit)
  - Improve and incentivize use of Public Transportation (e.g., more frequent, more affordable, more competitive, more effective, etc.). Extend Buffalo's MetroRail.
- Electrification of vehicles
  - Charging infrastructure
  - Equitable access to electric vehicles
  - Support for commercial vehicle electrification

### **Consumption and Waste Reduction**

- Local food production and procurement - provides resiliency, reduces food deserts, assists local economies, bolsters emergency food systems for production and procurement
- Address Food Waste through donations, reduction of waste, composting and digesters
- Reduce consumption, increase reuse and recycling to reduce solid waste

### **Climate Resiliency**

- Vulnerability assessment
- At-risk populations, disparate impact, disadvantaged communities
- Hazard and population specific planning and program development

### **Nature Based Solutions**

- Protection, preservation, repair and healing of land and water, especially using native plants and forestry practices
- Increasing urban tree canopy in urban/suburban communities to improve human health and resiliency to flooding and extreme temperatures, as well as carbon storage
- Access to a diversity of green space and parks for all neighborhoods
- "Green" Infrastructure – using natural systems to improve water quality
- Agriculture and Forestry
  - Protect agricultural land for food production and carbon storage
  - Protect forests for carbon storage

### **Housing and Neighborhood Resiliency**

- Residential energy conservation
- Housing and energy affordability (NYS goal of less than 6% household energy burden)
  - Erie County Low Income Program for Sustainable Energy (ECLIPSE)
  - Tenant and utility ratepayer protections (rent, eviction, split incentives, stranded fossil fuel assets, COVID-19, ESCOs)
- Healthy, Supportive Housing – indoor air quality, lead, weatherization/energy efficiency, comfort, COVID
- Decarbonization (new construction/existing buildings)
  - Regulated multifamily affordable housing (5+ units)

- Naturally occurring single family affordable housing (1-4 units)
- Market rate housing
- Codes and standards
- Gentrification and anti-displacement
- Access to capital (redlining/greenlining)

### **Economic and Workforce Development**

- Sustainable development scorecard
- Transit oriented development with affordable housing requirements
- Family sustaining green jobs and career pathways
  - Priority populations and disadvantaged communities
  - Transportation access and equity
- Improve internet access
- Local/Regional manufacturing and supply chains
- Best value contracting, MWBE participation, and procurement
- Just transition support for workers, communities, and local governments dependent on fossil fuel industries

### **Agriculture and Food Systems**

- Farmland protections
- Engage local environmental organizations to encourage farmers to use farming practices and technologies that protect the health of people, animals, soil, air, and water and are sustainable.
- Provide resources, support, incentives, and promotion of farmers to encourage food production methods, such as sustainable and organic practices, to increase their customer base.
- Support the creation of a consumer-producer-buyer verification process to support and increase consumer purchasing
- of healthy and local food.
- Promote the inclusion of food systems as part of climate resiliency and/or disaster mitigation planning efforts.
- Encourage sustainable siting of large-scale renewable energy projects so that prime farmlands are not negatively
- impacted.
- Support, promote, and broaden participation in the Greater Buffalo Urban Growers Pledge.
