# Bureau of Weights & Measures

## **Our Mission**

Ensure that equity prevails in the marketplace.

## **About**

The Bureau of Weights & Measures is committed to providing consumer protection.

Regardless of industry, any place where a consumer buys, sells or trades based on weights or measurement, the Bureau of Weights & Measures is there! We are continuously training and procuring modern equipment to keep current with market trends.

The Weights & Measures Division inspects, tests, and certifies the accuracy of all commercial weighing and measuring devices, including gasoline and other fuel pumps or meters in Erie County. It is responsible for enforcing all applicable laws, rules, regulations and ordinances prescribed by the New York State Department of Agriculture and Markets and the County of Erie. It ensures that buyers and sellers of commodities base their transactions upon accurate weights, measures or counts by confirming all commercial devices' accuracy and proper usage. It also checks that all commercial devices within the county are accurate and constructed to prevent fraud.

The bureau receives revenue from civil penalties assessed for violations of the New York State Agriculture and Markets Law and Erie County Local Law 7 (1997). In 1989, the Bureau enacted a user fee system to help defray this Division's cost to the taxpayers. In 1997, this Division joined forces with New York State's Weights and Measures to test the octane of petroleum products within our county. The State fully reimburses the cost of this program. In 2019, Erie County passed the Consumer Protection Act of 2019 which created a Division of Consumer Protection and united the Bureau of Weights and Measures within the Department of Public Advocacy for Erie County.

# Bureau of Weights & Measures

## Availability

The Erie County Bureau of Weights & Measures is always on the job protecting consumers in many ways, often going unnoticed in the marketplace.

We are available during business hours to answer any consumer questions and investigate complaints.

The staff consists of Deputy County Sealers and Scanner Accuracy Examiners who are constantly inspecting devices and businesses. The inspections they conduct ensure consumers are receiving the proper amount of goods and services at the appropriate prices.

## Deputy County Sealers

Ensure the accuracy of all devices that sell goods and services in both retail and commercial environments. These devices include:

- Scales
- Gas pumps
- Linear measuring devices
- Vehicle scales
- Fuel delivery trucks
- Asphalt/ grain hopper
- Milk tanks

Inspections are conducted at grocery stores, deli, farms, pharmacies, scrap yards, quarries, jewelry stores, gas stations, etc.

In addition, Deputy County Sealers continuously check gas pumps, ATMs and any device that accepts credit cards for illegal skimming devices.



## Scanner Accuracy Examiners

- Ensure accuracy of prices consumers pay and enforce Local Law 7 of 1997.
- Conduct scanner accuracy audits; hold stores accountable to a high accuracy standard.
- Inspect stores for item pricing or shelf tags for all merchandise so the consumer knows the price they should be paying.
- Enforce the Super Refund Program, by providing justice for consumers who have been overcharged during sales transactions.

## Super Refund Program

Erie County Bureau of Weights & Measures enforces the provisions of Local Law 7 (1997). At all establishments which are granted a waiver from item pricing, the store is required to pay out a 'super refund' when a pricing error occurs. This is 10 times the amount of the error, not less than \$1 or more than \$10, plus the amount of the error. They are required to properly fill out Erie County's Price Discrepancy Report and give a copy to the consumer.

ANY retail store in Erie County, with or without a waiver from item pricing, MUST honor the lowest advertised price (shelf tag, sticker on the item, sign in the window, or printed ad) and refund the difference in price to the customer if there is a discrepancy.

## Did you know?

Weights & Measures enforces all consumer protection laws and has the ability to stop the use of seized devices and packages that deprive consumers of adequate amounts of goods or services delivered.
