# IAM RESPONDING UPDATE MOBILE APP NOTIFICATIONS

Our team is aware of an issue where, in some cases, users are not receiving push notifications from the lamResponding app when an incident is received. Our engineering team is actively investigating and working to resolve this issue as quickly as possible. Please note that all other functions within the lamResponding app are working as expected.

#### Steps to Resolve App Notification Issues:

If you are experiencing this issue, please follow these steps, as they have been effective in resolving this issue for most users:

# 1. Ensure your Device's Operating System is Up to Date

• Check for and install any available updates for your device's operating system.

#### 2. Delete All Agencies within your lamResponding App

- Access the agency list by selecting the agency name at the top of the app menu.
- Delete each agency shown on the list. This will disconnect your device from your member profile for each agency.

# 3. Delete and Reinstall the lamResponding App

- Uninstall the lamResponding app from your device.
- From the App Store (iOS) or Google Play Store (Android), download and reinstall the latest version of the lamResponding App.
- Open the lamResponding app and log back into your account(s).

#### **Alternative Notification Methods:**

To ensure that users continue to receive incident notifications, we encourage users to utilize multiple notification methods supported by lamResponding. In addition to app push notifications, laR will also send alerts via email and text (SMS).

These alternative methods help to ensure users are receiving critical notifications in a timely manner.
