ECSD No. 1 Board of Managers Recommendation for Approval

Bids were opened for Erie County Sewer District (ECSD) No. 1, Contract No. 46, Electric Ave. and Casimer St. Replacement Project on April 2, 2024. Five (5) bids were received. Three (3) of the bids was determined to be non-responsive due to Local Law requirements missing at bid; therefore, only two (2) bids could be considered for Contract No. 46. The total cost submitted by the low bidder, Visone Construction, Inc. was \$200,112.45. This is below the Engineer's Estimate of \$245,793.00. The second lowest bid was \$239,713.65; therefore, the lowest bid is considered competitive for the work specified. The bid tabulations, Engineer's estimate and Engineer's recommendation are enclosed.

The Division of Sewerage Management (DSM) has reviewed the bid and believe it is fair. The bid package was complete and properly filled out. Visone Construction, Inc. has submitted a responsive bid. The contractor has been recognized as a responsible company and has successfully completed projects of this scale for the DSM in the past. The County's EEO office is currently reviewing the proposed M/WBE and SDVOB Utilization Plan. The Erie County Department of Environment and Planning recommends the award of Contract No. 46 to the aforementioned lowest responsible bidder. The funding source would be through the ECSD No. 1 Capital Bond Account C.00057.

The DSM would like to have this item considered by the ECSD No. 1 Board of Managers at the next Board meeting which is scheduled for April 19, 2024. For your use, I have enclosed a resolution for formal recommendation of the award of Contract No. 46.

Engineer Recommendation

Bids were opened for Erie County Sewer District (ECSD) No. 1, Contract No. 46, Electric Ave and Casimer St Sanitary Sewer Replacement Project on April 2, 2024. Five (5) bids were received. Three (3) of the bids were determined to be non-responsive due to local law requirements missing at bid, therefore, only two (2) bids could be considered for Contract No. 46. The bid tabulations are enclosed. The total cost submitted by the low bidder, Visone Construction, Inc. was \$200,112.45. This is below the Engineer's Estimate of \$245,793.00. The second lowest bid was \$239,713.65; therefore, the lowest bid is considered competitive for the work specified.

The Division of Sewerage Management (DSM) has reviewed the bid. The bid package was complete and properly filled out. Visone Construction, Inc. is experienced in the type of work specified for this project. They have successfully completed projects of this scale for the DSM in the past. Visone Construction, Inc. is recognized as a responsible company and capable of being able to provide the necessary manpower and equipment for this contract. The County's EEO office is currently reviewing the proposed M/WBE and SDVOB Utilization Plan.

Per Local Law No. 2 (2021), the ten (10) calendar day period for receipt of public comments pertaining to bidder responsibility has elapsed and no comments have been received by the Commissioner.

It is recommended that the Contract be awarded to Visone Construction, Inc., Inc. at a total bid of \$200,112.45.
