WHEREAS, the Erie County Sewer District No. 3 Board of Managers has been advised that Southtowns Advanced Wastewater Treatment Facility Ash Landfill Reclamation Project Contract No. 82 has been satisfactorily completed; and

WHEREAS, the Erie County Department of Environment and Planning recommends the acceptance of the Southtowns Advanced Wastewater Treatment Facility Ash Landfill Reclamation Project, Contract No. 82 (General Construction), in the final contract amount of \$1,714,365.05 together with Change Order No. 1 (final) a decrease of \$305,351.45; and

WHEREAS, the Erie County Department of Environment and Planning recommends Contract No. 82 with Union Concrete and Construction Corp. be finalized.
