- Introductions
- Speaker: Lisa Kenney from the Greater Buffalo Niagara Regional Transportation Council. Lisa talked about a forum they are having on driverless cars. It will take place on Saturday August 3, 2019 9:30am-5:00pm. They will be discussing the safety of driverless cars; the access driverless cars will provide the disabled and those who do not drive. There will be \$100 stipend for those participating.
- David Wantuck from Deaf Access Services introduced himself and told us about his new role as Community Engagement Specialist.
- Frank let the group know that July 26, 2019 is the Anniversary of the singing of the Americans with Disabilities Act. Saturday July 27, 2019 will be the Disability pride parade and Festival. accessible machine available at one location per community, and one per legislative district in the City of Buffalo. Strongly recommend using Disability machine, anyone can use the machine. Do not let a poll person tell you otherwise. David will be sending Frank some questions regarding ASL and the machines to ask the board of elections.

- Frank reported that October will be a busy month, activities including; career fair, National Disability Awareness Conference, Voter event, Outreach table at Central Library that will feature a different organization every day.
- Amy Bombas from the US Census will be at August meeting.
- Patti Ann reported she is attending a closed POD meeting with OPWDD, not
