U.S. Environmental Protection Agency (EPA)
Lead Safety for Renovations, Repairs, & Painting (RRP) Course

The **EPA RRP RULE** requires that all renovations, repairs, & painting performed in Pre-1978 housing must be done by or under the supervision of a **CERTIFIED RENOVATOR**. This means that **ALL LANDLORDS, PROPERTY MANAGERS, & CONTRACTORS** are required to take this course. Upon completion of the training you will be an EPA Certified Renovator able to work on any Pre-1978 dwelling. Program staff will be on hand to assist in the completion of the **REQUIRED WORK PLAN**.
