

### "Advancing CRR for New York Fire & Life Safety Educators"

### Karen Berard-Reed - Community Risk Reduction Lead - National Fire Protection Association

Attendees will explore the process outlined in NFPA 1300, the "Standard on Community Risk Assessment and Community Risk Reduction Plan Development", and identify entry points into local practice. Discover how CRR can modernize safety initiatives and enable departments to operate with efficiency, equity, and impact. Whether you're just starting with CRR or refining existing strategies, this session offers the tools and insights you need to amplify your department's effectiveness and elevate safety across New York. Lead the transformation that protects our firefighters, our neighborhoods, and the New Yorkers we serve every day.

Karen Berard-Reed, M.Ed., is a Senior Strategist leading the Community Risk Reduction initiative at the National Fire Protection Association. Karen develops innovative tools and resources to assist stakeholders who are focused on data and standards-driven processes to improve community safety. Her contributions include training, partnership-building, and critical tools to support CRR efforts such as CRAIG 1300™, the NFPA Community Risk

Assessment Insight Generator and the CRR Kitchen Table, a monthly virtual gathering of prevention-minded professionals. Karen previously managed NFPA's high-risk outreach activities and created safety education materials for young children, older adults, and underserved communities. Karen serves on the IAFC Fire and Life Safety Section Board of Directors, the NASFM Core CRR team, the Vision 20/20 steering committee and has served as an instructor at the National Fire Academy. Before coming to NFPA, Karen worked in the health promotion field in K-12, higher education, and community settings.

### John Buttino



John Buttino is a Fire Protection Specialist with the New York State Office of Fire Prevention & Control currently assigned to the Fire & Life Safety Branch in Buffalo, New York.
