









 - Committee is working on making information about recovery, behavioral health issues including Mental health, Substance use Disorders and Co Occurring disorders more readily available to family and natural supports.

2020 Has Seen a Sharp Increase in Number of Opioid Related Deaths

Almost 20% of adults in the US have a mental health condition

If you don't know where to begin getting addiction and/or mental health help

for yourself or someone you know, we can help.

Things to Know About Addiction and Mental Health Conditions:

- THERE IS HOPE. Individuals recover from addiction and mental health conditions every day. An individual can take concrete steps to put the symptoms into remission.
- Addiction and mental health conditions are both diseases, not a moral failing or personality defect. Both are lifelong, chronic diseases of the brain.
- There are treatment options available. Just as each person is unique, there are many different options available to treat addiction and mental health conditions.
- There is support for family and friends of someone who has an addiction or mental health condition.
- Get trained and carry Narcan (a nasal spray which temporarily reverses an opioid overdose). This has saved thousands of lives and is available at local drug stores without a prescription. More information can be found by searching Narcan on YouTube or texting Erie County Department of Health at to get Narcan mailed to you.
- If you or your loved one, isn't ready to address the addiction, harm reduction is a way to try and minimize the negative consequences of use.

 - This workgroup was developed to identify adolescent prescribers in the County and provide a reference document to the community
 - Practitioners were identified and the clinics in which they prescribe

 - Although the list will be fluid and still in process of development the committee is closing in on a final draft. Adding some providers, verifying locations, contact information, and accepted insurances

- Improve access to Medication Assisted Treatment in the Community
 - Facilitator: Jennifer Seib, <u>JSeib@bestselfwny.org</u>
 - Committee has spoken to some primary care physicians who will be looking to
 join the committee's next meeting, so that is an exciting step.
 - Dr. Tilabeth Doscher working with Endeavor to provide low-threshold access to people who are seeking Medication for Opioid Use Disorder (MOUD). These individuals are currently being referred through Save The Michaels.
 - After presenting at the August 19th WNY Regional Planning Consortium, Dr.
 Doscher is continuing her work with the WNY RPC Managed Care Group to
 incorporate viewpoints of providers into what creates barriers to their providing
 treatment to individuals with SUD.

 - Committed to modifying the Adult Single Point of Accountability/Access algorithm that calculates a risk score for housing referrals. Will ensure it captures SUD events such as overdoes, detox, and inpatient admissions
 - Early stages of exploring various SUD housing projects. While in the initial review stages, Living Opportunities of DePaul and Saving Grace Ministries are exploring a potential project. There remains an encouraging level of interest, involvement, and enthusiasm to collaborate to meet this need.
 - While not the result of this Committee's facilitation, other affordable housing projects have also been developed,

- Increase access to SUD Housing, cont.:
- BestSelf Behavioral Health's (BBH) and Matt Urban Center HOPE HOUSE:

Hope House (formerly PS57) is Matt Urban and BestSelf Behavioral Health' 27 unit apartment complex located at 243 Sears street, Buffalo and is funded by the ESSHI project. 17 of the 27 units must meet MRT eligibility criteria.

Criteria

A primary diagnosis of a Substance Use Disorder;

Active Medicaid or eligible for Medicaid and to be enrolled;

A history of two inpatient hospitalizations, <u>or</u> five emergency room visits; within the past 12 months; or one inpatient and three ER visits;

Enrolled in or eligible to enroll in a Health Home;

Single adult living alone; and

A history of or currently at risk for homelessness

Units

13 studios

10 one-bedrooms

4 two-bedrooms (these are family units and referrals are received from the Light House)

- Increase access to SUD Housing, cont.:
 - BBH Rapid Rehousing Program:
 - Rapid Rehousing funded through the City of Buffalo with ESG funding.
 - A two-year program utilizing Federal COVID-19 funds to aid displaced individuals and families affected by the pandemic to locate suitable and affordable housing within a 30 day time period. This program assists with time limited housing relocation and stabilization services. Referrals are received through the Homeless Alliance of Western New York HMIS coordinated entry process and are prioritized based on risk factors. BBH can assist up to 50 individuals or families per year.

- Increase access to SUD Housing, cont.:
 - **Spectrum Human Services** Covid-19 Rapid Rehousing Beds:
 - City of Buffalo Covid-19 RRH Participants would need to be housed in the City of Buffalo = 45~ beds
 - Erie County Covid-19 RRH Participants can be housed anywhere in Erie County = 37~ beds
 - Both programs are considered permanent housing participants are assigned a housing worker who will meet with the client at least once a month to work on a goal (goals can be maintain housing/secured benefits/ or obtain employment). Rental Assistance can be provided up to 24 months
 - Eligibility Criteria:
 - Low barrier/Housing first model approach
 - Participants must meet the HUD definition of Category 1
 homelessness: meaning literally homeless, is defined as an individual or
 family who lacks a fixed, regular, or adequate nighttime residence.

- Increase access to SUD Housing, cont.:
- Eligibility Criteria:
 - Spectrum will not screen out or exclude participants based on any of the following:
 - Failure to participate in supportive services or make progress on a service plan
 - Having too little or no income
 - Refusal to participate in drug tests
 - Active or history of substance abuse
 - Experience of domestic violence (e.g. lack of a protective order, period of separation, etc.)
 - Credit or eviction history
 - Failure to participate in a probation or parole program
- How to refer clients to Spectrum's Covid-19 Rapid Rehousing
 - Referrals are ONLY through WNY Coordinated Entry Jacob Hoffman is the Coordinated Entry Lead for this Continuum of Care (CoC) – 716-208-3748;
 - Or go to Harbor House Resource Center 7am-3pm 716-832-2141x105 to be assessed and be inputted into the By-Name Priority pool

- Increase access to SUD Housing, cont.:
 - Cazenovia Recovery Systems: Garden Lofts
 - Offering permanent housing with 23 studio apartments
 - 2211 Main Street
 - Adults recovering from SUD who are homeless or at risk of becoming homeless
 - Completed their SUD treatment

Mission Statement



NY/NJ HIDTA Mission Statement

The mission of the NY/NJ HIDTA is to reduce drug trafficking and its harmful consequences, particularly drug related crime, by building innovative and effective partnerships with law enforcement agencies operating in the New York/New Jersey region. HIDTA-funded initiatives aim to facilitate timely and accurate sharing of criminal drug intelligence among these agencies, enabling them to more effectively target regional and international drug trafficking and money laundering organizations, drug gangs, drug fugitives, and other serious crimes with a drug nexus. In addition, the NY/NJ HIDTA is partnering with public health agencies and law enforcement agencies in the region to better evaluate trends in illicit drug use and develop more targeted outreach and prevention campaigns.

National HIDTA Mission

The mission of the National HIDTA Program is to disrupt the market for illegal drugs in the United States by assisting federal, state and local law enforcement entities participating in the HIDTA program to dismantle and disrupt drug trafficking organizations, with particular emphasis on drug trafficking regions that have harmful effects on other parts of the United States.

Gathering Data ODMAP

ODMAP combines street-level data with tools from Esri (digital mapping company). Assists public health officials, police departments, and first responders track and respond to overdoses.

- Multiple jurisdictions
- Ability to set parameters
- Filter by week, month, quarter, etc.
- Filter by Narcan, fatalities, zip code, etc.

Narcan Trainings and deployment this quarter (10.1.2020 – 12.31.2020)

- Continued naloxone trainings and medication deployment conducted by the department, many are virtual or on the spot:
 - Law enforcement 220
 - Fire fighters 204
 - EMS/Healthcare Providers 111
 - Community outreach Opioid grant staff 391
 - Mailing 531 kits
 - Replacements for expired and virtual trainings for community and professionals – 187 kits




What's happening with naloxone/Narcan usage in WNY








ODMAP Data Range: 01/01/2020 - 12/29/2020 Naloxone FR Data Range: 01/01/2019 - 12/25/2020



Expansion Across New York State




Referrals Made at the ED Departments








Was buprenorphine given to patient prior to discharge?

- Continued partnership with Twin City Ambulance
- EMS crews "leave behind" naloxone at the scenes of any opioidrelated calls (homes, businesses, etc.)





Buffalo Police Department Telemedicine Program

- Program will begin Feb 2021
- Consults on scene via telemedicine for any opioid-related calls
- Patient will be assessed by EM provider
 - Ability to prescribe buprenorphine if appropriate and provide linkage to treatment via New York MATTERS





2016 CASES REVIEWED & COMPLETED

• Recommendations:

- MAT in the Correctional Facilities
- Access to care
- Continuity of care
- Drug Rehabs and Mandated court treatments completed successfully
- Focus on school age warning signs
- Red flag overdoses like any other chronic care morbidities



FINDINGS IDENTIFIED

- Most trauma that we are aware of occurs at the childhood stage
- Different trauma at different stages of life had a negative impact
- Nearly all are having interactions with law enforcement, and spending time in prison/jail
- Fentanyl related drug overdoses account for 70% of death
- Over 50% were prescribed pain killers at some point in their life
- Over 80% experienced at least one previous overdose
- Rehab was the most common treatment attempted with 70%, although many attempted more than one treatment option



2017

- 19 families interviewed
- 1st 2017 Board Review commenced 01/07/2021
- Rest of the cases scheduled and will continue to host virtual review boards

Opioid Unit Peer Navigation and Covid-19

- Peer Navigators are working from home 3 days weekly and come into the office 2 days weekly.
- Peer Navigators attempt to have regular phone contact with the probationers assigned to them. We are looking to increase the use of virtual platforms such as Facetime and Zoom.
- Peer Navigators are able to have face to face interactions with probationers when they report to their officers. The number of probationers seen in department is limited due to COVID-19 However, Peer Navigators are making arrangements to have face to face meetings in community settings.

Opioid Unit Probation Officer and COVID-19

- The Probation Officer prioritizes those probationers that are struggling and has them report to the office in person.
- The Probation Officer has been making regular home visits while following department guidelines (not crossing the threshold of a residence). When an initial home visit occurs, both the Probation Officer and Peer Navigator attend.
- The Probation Officer keeps in contact with the probationer and their service providers, as well as specialty courts.

Erie County Department of Probation Department TCU V Screenings

Total TCU V screenings completed July 2019 through December of 2020 was **2,046**.

Of those, **116** (5.67%) individuals scored a 6+ with an identified Opiate problem.

Since July of 2019, **43** probationers have been linked with the Opioid Unit.


An additional **30** probationers assigned to outside of the Opioid Unit have been linked with a Peer Navigator.

Erie County Department of Probation Department Wide Overdoses July 2019 – December 2020

- Total Opioid Overdoses: 56
 - Of those, 5 probationers had more than one OD
 - 42 were Non-Fatal
 - 14 were Fatal
 - 9 of the Non-Fatal OD's occurred with probationers on the Opioid Unit

In reviewing the ECDP Overdose information, we wanted to ensure that probationers not already linked with the Opioid Unit are all consistently offered Narcan and the support of a Peer Navigator after an OD event. We have set up a process, shared with all department Officers, to make certain this is occurring.

Count of MAT Medication Type July 2019 - December 2020




Of the 43 probationers that have been assigned to the Opioid Unit 28 are linked with MAT.






