

OPIOID RELATED DEATHS ERIE COUNTY



2015 – 2019* ERIE COUNTY OPIOID RELATED DEATHS BY AGE






2017 – 2019* PERCENT OF ERIE COUNTY OPIOID RELATED DEATHS BY RESIDENCE










CPS LAB OPIOID ANALYSIS ERIE COUNTY, 2014-2019




2018 Erie County CPS Forensic Lab



The 30 different opiate combinations contain mixtures of 2-5 the following substances in a single exhibit (other than heroin combined with fentanyl): cocaine, heroin, fentanyl, butyryl fentanyl, furanyl fentanyl, acetyl fentanyl, U47700, tramadol, 4-Fluoroisobutyryl fentanyl and 4-Anilino-N-phenethylpiperidine.
