







2012 – 2023* OVERDOSE DEATHS ERIE COUNTY 2016: 7% OF










2022 AND 2023* PERCENT OF ERIE COUNTY OPIOID RELATED DEATHS

2017 - 2022 PERCENT OF ERIE COUNTY OPIOID RELATED DEATHS





Xylazine (AKA Tranq)

- Xylazine is an animal tranquilizer used for sedation/pain relief
- Xylazine is increasingly found added to illicit drugs, especially fentanyl



- In humans, xylazine overdose causes major toxicity
 - Coma, low BP, cardio-respiratory arrest
 - Disfiguring skin ulcers after repeated injections that can lead to gangrene and limb amputations
- Treatment consists of supportive care, i.e., ICU admission, intubation, etc.
 - No rapid diagnostic testing or safe antidote available
 - Xylazine poisoning is <u>not</u> responsive to naloxone

Opioid Related Death Updates Erie County

Substance Updates

- Xylazine identified in 13 deaths in 2022
- Methamphetamine identified in 28 deaths in 2022
- ↑↑ OD deaths with NO opioids from 2016 (7%) to 2022 (19%)
- Cocaine identified in 173 (57%) opioid deaths in 2022
 - 35% of opioid with cocaine deaths among black persons (black persons = 14% of total Erie Co population)
 - 29% of opioid with cocaine deaths among aged 50-59 years (50-59 year old = 14% Erie Co population)

HEALTH CARE PROVIDER EDUCATION AND POLICY REFORM ACTIVITIES UPDATE

MOUD in community primary care

- DEA buprenorphine prescribing restrictions lifted
- Primary care opportunity to identify and treat patients with OUD
- Given current health plan reimbursements, community providers report financially difficult to sustain MOUD

MOUD in community primary care

- Next steps:
 - Key informant interviews to better understand challenges
 - Work with NYSACHO and Erie County Medical Society to attempt to make needed changes

 - Support specifically for family/support systems (support groups, family peer support, education/prevention for different ages)


The Treatment Workgroup has had <u>preliminary</u> discussions around two possibilities:


- 1) Those with <u>stimulant use disorders</u> are increasingly susceptible to overdose. How can we better reach and treat them?

WNY Opioid Addiction Treatment 24/7 Virtual Medication Assisted Treatment Center


- 419 Unique Individuals have been prescribed medication via the program
 - 204 Erie County
 - 183 Niagara County
 - Calls from Allegany, Wyoming, Orleans, Genesee, Chautauqua, and Cattaraugus range from 4-48 per county – 109 Total Calls from these 6 Counties
 - 3 callers identified as homeless
- 461 unique individuals referred to prescriber for MAT eval
- 533 MAT prescriptions provided
- People continue to be linked with the provider of their choice, for ongoing care, across the WNY counties

Treatment Agency Highlights

- Caz Recovery transitioned their OASAS-certified 819 Supportive Living Program to 820 Reintegration (scattered site) now named <u>Step Toward Success</u>
- Program Information:
 - Features peer-supported apartments with wraparound support services for adults with SUD
 - Apartments located in Erie and Niagara Counties
 - Suitable for individuals further along with recover and can maintain a degree of independence with some structure and support.
 - Ideal candidates will have completed previous residential SUD programs and will need to be enrolled in outpatient treatment







Erie County Cannabis Update April 2023

based on updates from the NYS Office of Cannabis Management

- The injunction is lifted allowing legal and regulated recreational marijuana dispensaries to open in WNY.
 - ▶ There were three conditional adult-use dispensary licenses awarded in Erie County.
- There continue to be operational dispensaries on Native land which to distribute both medical and recreational cannabis based on sovereign regulations.
- ▶ In Erie County, several additional conditional licenses have been approved:
 - 9 conditional cultivator licenses
 - 2 conditional processor licenses



We continue to be asked about fentanyl in cannabis. We are not seeing this locally or at the state level.

What are we doing?

Educating:

- Edible packaging may contain more than what one person should consume as a serving prompting educational materials advising "Start low, go slow."
- ► Each method of ingestion metabolizes at different rates based on the person consuming the product
- ► Encouraging research and communication with dispensaries about their products and their effects
- ▶ Strict packaging requirements with the goal of preventing use in minors including restricting character advertisement, labeling as an already existing product and catch phrases.
- ▶ Childproof packaging will be available for purchase or provided with each sale
- Cannabis in the home should be locked and out of sight of children



Labeling Regulations

- All licensed dispensaries can be verified using the Dispensary Verification Tool which should be posted in the storefront.
- All products must contain the approved warning label.



Changing the Message Teaching People How to Treat People

- No One Deserves to be Poisoned
- Predatory Fentanyl Dealers are not People Who Use Drugs (PWUD)
- We shouldn't have to Wait for Anything to develop a flexible plan to save Lives
- When the Message Changes, Community Response will Change

Compassionate Interaction is Harm Reduction

 Every interaction can be an opportunity to express low impact help and personal care

 In many cases, the person developing a problem doesn't know what is happening to them

 Food, shelter, clothing and medical care are basic human needs

Harm Reduction Includes

- Connect individuals to overdose education, counseling and referral to treatment for infections diseases and SUD
- Distribute opioid overdose reversal medications
- Lessen harms associated with drug use; Hepatitis, HIV, infections
- Reduce infections disease among PWUD
- Promote a philosophy of hope and healing by utilizing those with lived experience.

Findings Regarding Health Care and SUD

- MAT programs were mentioned as an option to 63% (n=17) of participants and were not mentioned by healthcare providers to 37% (n=10) of these participants. More research is needed to understand the reasoning behind MAT programs being unavailable to some people struggling with SUD since they are proven to be effective in helping with opioid addiction.
- It was found that many of the participants did seek out help from the healthcare system for OUD, in that 71.4% (n=20) did seek out help, and 28.6% (n=8) did not. Of those, 59.3% (n=16) were not able to find a physician that properly helped them with their OUD, and 40.7% (n=11) did. These numbers indicate that even when seeking out professional help more than half of the respondents were not able to find someone to properly help them with OUD.
- When it comes to SUD the healthcare system in 2017, spend an estimated \$35 billion dollars which include costs spent on healthcare and opioid use disorder treatment (Centers for Disease Control and Prevention c, 2021).


Findings Regarding Harm Reduction

- This method is focused on reaching the "unreachable" by meeting the substance users where they are at instead of focusing on the traditional abstinence prevention model (Einstein, 2007). This approach is newer and not as widely accepted by society or the healthcare system.
- When participants were asked if the healthcare system spoke to their loved one about harm reduction 40% (n=10) indicated "yes" and 60% (n=15) indicated "no". This shows that more than half the respondents were not given the option of this type of treatment.

Findings Regarding Criminal Justice

• In this research study, participants were asked if their loved one was ever involved with the criminal justice system because of opioid use. It was found that 82.1% (n=23) indicated "yes" and 17.9% (n=5) indicated "no". This indicates that OUD does influence the criminal justice system.


• Therefore, the next question asked was whether they thought any particular services provided by the criminal justice system seemed to be helpful to their loved ones. It was found that 64% (n=16) did not feel the criminal justice system provided helpful services to their loved ones and 36% (n=9) did.



• In figure 5 it is noticed that 81.5% (n=22) indicated "yes" and 18.5% (n=5) indicated "no". More than half of respondents indicated that if they found the services to be friendly they would have maintained contact. A friendly service opens lines of communication and makes the individual feel safe and free of judgment based on OUD. If the service is friendly with the individual, they are more likely to continue with the service and use it based on these findings.

Harm Reduction Kits

Do you think harm reduction kits would have been helpful for your loved one? (example: fentanyl test strips, naloxone, alcohol wipes, water bottles, ...und care, a metal receptacle, clean syringes, pipes) ²⁸ responses



• Since there is a stigma around harm reduction tool kits enabling loved ones to continue using, this could be why more participants indicated "no" to this question.

Findings Regarding Mental Health

- It was found that 71.4% (n=20) battled also with a mental health disorder.
- Respondents also were able to indicate which mental health disorders their loved ones were diagnosed with, those included: Bipolar disorder (BD), anxiety, depression, Attention-deficit/hyperactivity disorder (ADHD), Obsessive-compulsive disorder (OCD), Post-traumatic stress disorder (PTSD), borderline personality disorder (BPD), and schizophrenia.
- Out of all these mental health disorders, anxiety and depression were more frequently found then others.

Findings Regarding Treatment

- The loved ones in this study indicated that 74.1% (n=20) had attended some sort of treatment for SUD throughout their addiction. This means that 25.9% (n=7) did not participate in treatment for their addiction.
- Participants expressed that of the treatment options their loved ones attended, rehab, MAT programs, and counseling to be most helpful.
- Majority of the responses (n=8) found MAT programs to be most helpful. This finding is not surprising since other research that has been done found that medication-based treatment is effective in supporting safe and less agonizing withdrawal, reduced mortality rates, and promotes functionality in the family, community, and society (Leshner et al., 2019).
- Even though MAT programs are proven to be effective, it is still limited in its availability, and there is misunderstanding which surrounds medication treatment (Leshner et al., 2019; Mojtabai et al., 2019).

Families Need Help

• WHEREAS, dangerous and powerful opioids, such as fentanyl, are increasingly being found on our streets, in addition to heroin; and

• WHEREAS, no single strategy alone can address this complex, multifaceted issue; and

• WHEREAS, coordination of the many individual anti-opioid initiatives currently being undertaken throughout Western New York is critically needed.

An Identified Community Need?

- An Appropriately Staffed central location to provide accurate, reliable information of the disease of Substance Use
- A central list of resources in the community
- Educational materials and hands-on training to show best practices in keeping people alive, wound care and disease management
- The ability to make a health care plan from evidence-based practices that is flexible
- Educational displays to show the history of opioids, the biology of opioids and the present-day concerns for our community






Total Suicides 2018-2022




2022 Suicides by Biological Sex




2018-2022 Suicides by Biological Sex




2022 Suicides by Race




2018-2022 Suicides by Mode
