



Established in 2016 under the name of the Erie County Opiate Epidemic Task Force, the group reorganized in early 2024 as the Erie County Overdose Prevention Task Force (OPTF).

The Erie County OPTF provides a framework for organizations and individuals to collaborate, develop and implement best practices that build stronger clinical and community supports for people with substance use disorder, people who use drugs, and their families, and advocate for policies and systems changes that will save lives and prevent overdose deaths.

Quarterly meetings and regular workgroup sessions provide forums for data reporting and information sharing, planning and highlighting successful initiatives.







<u>Buffalo</u> 29% of persons who live in Erie County reside in the City of Buffalo

86% of overdose deaths that occurred in Buffalo in 2023 were residents of Buffalo, up from 76% in 2016

Majority of people tend to use substances in their own home


- 64% of fatal overdose victims in 2023 died at their home address

## 2023 All Fatal Overdoses by Location of Overdose




### 2017 – 2023 PERCENT OF OVERDOSE DEATHS BY SUBSTANCES DETECTED ERIE COUNTY

## **Overdose Deaths Demographic Summary**

Overdoses among Black persons doubled from 2018 (13% of total) to 2021 (25% of total) and continue to increase each year (32% in 2023)

Overdoses among persons over age 60 almost double from 2022 (13%) to 2023 (24%), remain high in 2024 data (21%)

Overdoses among persons age 20-29 remain low after years of decline

• Fell from 24% in 2018 to 8% in 2023

### 2023 Overdose Deaths Toxicology Summary Xylazine detected in 18 deaths in 2023

• from 13 xylazine detections in 2022

Methamphetamine detected in 36 deaths in 2023

• from 28 methamphetamine detections in 2022

Benzodiazepines detected in 18 deaths in 2023

• from 55 detections in 2022, substantial decrease


Cocaine detected in 310 deaths in 2023, 71% of total





#### Naloxone Use Incidents by Location of Overdose, November 2023 – April 2024




# Non-Fatal Overdose Summary

Highly concentrated in northern Black Rock (14207) and near Allentown (14201)

Activity intensifying in Grant Ferry (14213) after unusually quiet period

West Seneca (14224) is an emerging area of concern

High concentration of fatal reports on East side of Buffalo, relative to non-fatal reports in the same time period

# Hospital based OUD identification and treatment

Lead: Dr. Jeffery Lach

Aim: identify SUD among patients admitted to hospital and continue or start opioid agonist therapy (OAT) for patients with OUD

Status: Preparation work of reviewing current policies and chart reviews

- Reviewing current hospital SUD screening practices and identifying potential improvements
- Examining hospitalized OUD patients' "against medical advice (AMA) discharge" data to explore potential relationship with lack of OAT during hospitalization

# Community physician office-based OUD identification and treatment

Aims: to develop strategies to facilitate physician offices to

- Routinely screen patients for SUD
- Start and follow patients with OUD on OAT

SUPPORT GROUPS AND FAMILY SERVICES | Join a support group that's built to meet your unique needs and life circumstances. We offer a variety of support groups for individuals who use substances, in addition to groups for the loved ones of people who use substances.

COUNSELINGFOR PEOPLE WHO USE SUBSTANCES | Explore the role substance use plays in your life in one-on-one or group counseling with our non-judgmental and understanding counselors.

PEER SERVICES: Connect with peers with shared experiences who want to share how they've been successful in meeting their recovery goals around substance use, including physical and mental health.

DROP-INCENTER | If you are a person who uses substances and needs support with basic needs, you may be eligible to receive services at our drop-in center in downtown Buffalo for showers, laundry, snacks, peer and staff support, and connection to other health care services.

#### Who is a Candidate for Low-Threshold Services:

- Individuals with Opioid Use Disorder and not currently on Medication for Opioid Use Disorder (MOUD) -OR- individuals currently linked with an outpatient program, but would benefit from low-threshold services instead
- Individuals who are not seeking or have challenges engaging in traditional outpatient services **What to expect:**
- Individuals will meet with a nurse and medical provider for evaluation and, if appropriate, prescription for MOUD and follow-up appointment.
- Certified Peer Recovery Advocates, Counselors, and Case Managers are available to assist, as requested
- There is no requirement to participate in any other service other than meeting with the medical staff for ongoing prescription for MOUD

#### How to get started:

- Individuals can call ahead or simply walk into the location and inform the front office staff they want to be seen in the low-threshold program. Have photo ID and insurance information ready
- Hours are:
  - Monday Thursday 8am-7pm
  - Friday 8am-4pm



## Background

#### **OPIOID EPIDEMIC**

- over **2,300** deaths 2012-2022
- 2016 was the height of opioid overdose deaths (OOD), at this time
- 2016 Executive Order 14
- 2017-2019 decline in fatalities
- despite the decline, Erie County was not immune to the "fourth wave" of the opioid crisis
- 2020-2023 overdoses increase
- over 350 OOD in 2023

## **Current Situation**

- Largest increase in opioid-related overdose deaths is now happening in people ages 60+ followed by people 50-59 years old
- Don't see themselves as active users
- Recreational cocaine users see themselves as very different from opioid users
- Mindset that overdoses are 'not going to happen to me'
- Older people don't understand what fentanyl is or how different it is than cocaine
- Misperception that opioid overdoses, deaths, and fentanyl related information is isolated to opioids (i.e., don't realize fentanyl is pervasive across the drug supply)

- Most don't realize that a leading driver of overdose deaths involve fentanyl-laced cocaine
- Most are surprised to learn that fentanylrelated overdose deaths are on the rise among older community members
- Mental health conditions (depression and anxiety) are co-occurring with substance use
- People still struggling during aftermath of COVID-19 social isolation

### Barriers

- **Stigma** how people will be perceived by community and family
- Mindset of harm reduction considered to be "enabling drug use"
- Lack of awareness of what fentanyl is/how it's different from cocaine and other stimulants; what harm reduction is; or what fentanyl test strips are
- **Triggers** include images of pills/needles
- Misperception that overdoses are happening among white youth (i.e., don't realize it's happening to older individuals and to communities of color)

## Campaign Audiences

- People at risk for overdoses
- Family members, friends, and community leaders to support harm reduction messaging, education, and activities

### Anticipated Media Placements/Outreach

- Radio and video (for streaming platforms)
- Coasters in bars and restaurants (often used for doing cocaine) and posters in bathrooms (which is where people are often using)
- Additional OOH ads and brochures at pharmacies, grocery/corner stores, gas stations, bus shelters and barbershops

- Working with leaders/influencers in Erie County (e.g., at churches, barbershops, etc.
- Free community papers like *The Challenger News* and *The Buffalo Criterion* for reaching Black communities (with online components)
- Paid social media

• Digital ads

## Next Steps

- Will present full Focus Group findings to Erie County DOH along with overall campaign concept
- Once the overall campaign concept and theme are approved, will move forward in creating a visual direction for the campaign this month
- Anticipate a photo and video shoot in Buffalo at the end of May/early June
- Tentative launch date: July 1 (with campaign lasting through Dec)

## Simultaneous to Formative Research...

- :15 sec radio ad with CTA to order test strips by visiting erie.gov/detect
- Began airing during Total Traffic and Weather Network segments and on WUFO on April 15
- Radio will continue until September
- Will revise based on campaign direction
- Tested with focus groups who gave positive feedback on campaign slogan of *Detect to Protect* and overall messaging
