Permits will be issued once this office receives the following:

1. Applications will be reviewed and approved on a first come, first case basis.
2. Bandwagon applications must be submitted four (4) weeks in advance.
3. The Bandwagon (Stage) is unavailable from November 15th – April 15th.
4. This completed application and accompanying agreement
5. Check or money order payable to the 'Erie County Parks' in the amount of \$475.00 per day
6. Certificate of Insurance listing the County of Erie as Additional Insured (see below).
7. The delivery and pick up dates and times of the bandwagon will be at the discretion of the Erie County Parks Department.
8. **NO DUCT TAPE, SCREWS OR NAILS CAN BE USED ON BANDWAGON**
