

NOTICE TO BIDDERS

NOTICE IS HEREBY GIVEN, that sealed proposals for the Erie County Sewer District No. 3 Southtowns Incinerator Tray Scrubber Replacement and Crane Installation Project Contract No. 68 will be received by the Commissioner of the Erie County Department of Environment and Planning on January 13, 2022 until 1:00 pm, local time, at 95 Franklin Street, Room 1034, Buffalo, New York, 14202, at which time they will be publicly opened and read aloud in Room 1004.

INFORMATION – PLEASE NOTE:

Given precautions due to COVID-19 recommended by New York State the County of Erie is requiring that all attendees of the Bid Opening for the above referenced project RSVP no later than January 12, 2022 at 4:00 PM local time.

Attendance at the Bid Opening is NOT mandatory.

Bids will still be accepted regardless of attendance at or RSVP to the Bid Opening. The County is restricting the number of attendees for the Bid Opening to only one (1) person per company and that person must wear a mask and complete a medical form. The attached confirmation page includes a section for the RSVP and name of attendee.

Project

The contract is located in Erie County Sewer District No. 3 (ECSD No. 3) at the Southtowns Advanced Wastewater Treatment Facility, S-3690 Lake Shore Road, Hamburg, NY 14219. Work includes supply and installation of air pollution control and associated drainage equipment, supply and installation of a stainless-steel ventilation stack following air pollution control equipment, structural work involving concrete and steel, supply and installation of a JIB Crane, and other work associated with the assemblies and structures.

Bidders are advised that a pre-bid meeting for the construction of this project is scheduled for December 16, 2021, at 2:00 P.M., Conference Room at Southtowns Advanced Wastewater Treatment Facility, S-3690 Lake Shore Road, Hamburg, NY 14219.

The bidding documents: Contract Specifications, Proposal and Plans may be downloaded directly from the erie.gov website <http://www2.erie.gov/dsm> “Online Bid Retrieval” tab, or may be examined at the office of the Erie County Department of Environment and Planning Division of Sewerage Management, 10th Floor, Room 1034, 95 Franklin Street, Buffalo, New York 14202. Following the bid opening, bid results will be posted at <http://www2.erie.gov/dsm> under the “Bid Results” tab.

Bidders shall complete the online form and submit their contact information when retrieving the bidding documents from the erie.gov website. **Bids will not be accepted unless the bid package is downloaded directly from <http://www2.erie.gov/dsm> so that contact information is captured for bid addenda and communication.**

The envelope containing the bid must be sealed, addressed to the Erie County Commissioner of Environment and Planning and must be clearly and correctly designated as

“Erie County Sewer District No. 3, Contract No. 68, Southtowns Incinerator Tray Scrubber Replacement and Crane Installation Project”. Bidders submitting a bid for more than one contract must do so in separately sealed envelopes for each contract. Any envelope containing more than one bid will be considered an improper bid and not opened. Any bids not delivered in person shall be mailed to the Erie County Commissioner of Environment and Planning, 95 Franklin Street, **Room 1034**, Buffalo, New York 14202, and received prior to the time set for the bid opening.

Erie County Sewer District No. 3 is an exempt organization under the Tax Law, and is exempt from payment of Sales and Compensating Use Taxes which are to be incorporated into the project and which are to be separately sold by the Contractors to the Owner prior to incorporation into the project, pursuant to the provisions of the contract. These taxes are not to be included in the bid. Sales tax will be due on all materials purchased by a Contractor which are either “consumable” or rental property used by the Contractor in connection with the construction or repair.

Each proposal must be accompanied by a certified check payable to the Erie County Comptroller or by a bid bond having a surety thereon from a surety company acceptable to the County Attorney, in an amount not less than five percent (5%) of the total base bid, as surety for execution of the contract.

The successful bidder will be required to furnish Payment and Performance Bond, each in an amount equal to 100 percent of the contract award.

Attention of the bidder is called particularly to requirements with respect to conditions of employment to be observed, minimum wages rates to be paid under the contract, Affirmative Action requirements for Equal Employment Opportunity, along with the Minority Business Enterprise Utilization Commitment. Bidders are also advised that Part “A” of the Erie county Minority Business Enterprise/Women’s Business Enterprise Utilization Report be submitted with the bid or no later than three (3) business days after the bid opening.

The attention of the bidder is called particularly to the provisions of Erie County Local Law No. 3-2018, known as the “Erie County Workforce Development and Diversification New York State Certified Worker Training Program”, to have in place and provide written proof at the time of bid, a New York State Certified Worker Training Program, either intentional to the Contractor or Subcontractor and/or through an organization servicing several Contractors or Subcontractors, appropriate for the type and scope of work to be performed. In the alternative, Rules and Regulations pertaining to Local Law No. 3-2018 allows the Bidder to provide a statement as to the inapplicability, lack of career opportunities, and/or that the magnitude of the contract would make apprentices impractical. Bidders shall also provide affirmation of its commitment toward acceptable achievement or progress toward the County of Erie workforce development and diversification goal of 13.2 percent minority and 6.9 percent female participation combined in project personnel including trades people, trainees, journeymen, apprentices and supervisor staff.

Attention of the bidder is called to the requirements of Erie County Executive Order No. 18 for hiring local and disadvantaged workers on Erie County construction projects. All bids must include a verified attestation of intent to comply and statement of work force.

The attention of the bidder is called to the provisions of Article 5A of the General Municipal Law which requires the bidder to execute a certificate of non-collusion and to conform with the other provisions of Article 5A outlined in the specifications. A form for such certificate accompanies the bid form. Unless it is properly executed, the bid will not be accepted.

Attention of the bidder is called to the requirements of Erie County Local Law No. 2 - 2021 the Lowest Responsible Bidder Law, bidders shall complete and submit the included Responsibility Questionnaire and Attachments A, B, and C.

The right to reject any and all bids, to waive any informalities in, or to make any award to other than the low bidder, should it be deemed to be in the best interest of Erie County Sewer District No. 3 and in accordance with Law, are herewith reserved.

No bidder may withdraw his bid within 45 days after the date set for the opening thereof, but may withdraw same any time prior to the scheduled time for opening bids.
