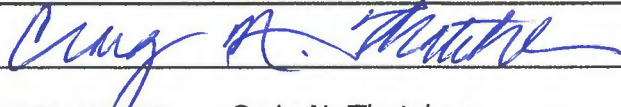

- To be biochemical treatment product that controls hydrogen sulfide odors and corrosion biologically.
