



SPECIFICATIONS

Generator Inspections

Inspection shall include travel to and from the site where the generators are located.

The vendor shall check the oil and coolant levels.

Visual checks shall include fuel system and injector pump solenoid, governor controls, linkages, block heaters, hoses, belts, clamps, air filters, breathers, exhaust systems, water separators, radiator condition, general leaks in all systems.

The vendor shall test the coolant for the protection level from freezing and for impurities.

The vendor shall change the oil, including replacement of the oil filter and fuel filter, on all generators equal to and under 300 KW annually.

The vendor shall collect an oil sample on all generators over 300KW and have it analyzed, and the results shall be in the form of an overall report when testing is complete.”

Gen-sets will be load bank tested at 100% capacity for a total of one hour, monitoring stepping up, full load and stepping down.

The load bank shall be provided by the vendor. Load Banks that are permanently installed for stationary generators can be utilized by the contractor for purposes of load bank testing on units. Load banks shall be 100% capacity unless otherwise noted. Southtowns generators (Detroit Diesel 800 kw) shall be load banked individually utilizing stationary load bank at the facility @ 700kw for a period of 1 hour including monitoring stepping up and stepping down.

Portable generators DO NOT need to be load banked.

The vendor shall load test the generator batteries.

A report is to include, battery condition, battery voltage and charging voltage, output voltage, frequency, loaded amps, oil pressure, water temp and hour meter reading.

The vendor shall note any deficiencies in a report, and provide an estimate for the recommended repairs following the inspection, with a detailed list of needed repairs.

Vendor shall provide repair services and/or repair parts for gensets upon approval from Erie County. Parts will be at cost plus documented mark up. Labor rates will be for regular time and overtime rates as indicated on bid and be for actual work performed. Travel time is not billable. All repairs and service work schedules will be approved and scheduled by Erie County for both annual inspections and repairs needed.

If oil and/or coolant needs to be changed as per testing then the above parts cost plus mark up and regular time labor rates would apply.
