**II. Youth Bureau Update-Wanda**

**i. Update regarding board members**

- a. Melissa stepped down from Youth Board. Wanda shared that as we have discussed, Melissa did not feel as though the change she hoped to make was being made and she was frustrated.
  - i. The Board needs to vote in a new Chair, but we need new members first as per the by-laws.
  - ii. Jamien shared that this is his second meeting as Vice Chair and is a bit concerned about what Melissa's resignation means for him and the Board and had further questions about when Melissa stepped down. Wanda noted it was a couple weeks ago.
  - iii. Wandra reminded the Board that this is the Board's meeting, and if changes need to be made, then the Board needs to discuss this and act. Wanda noted change takes time, but the Board does need to act for things to evolve.
  - iv. Wanda expressed that since new folks joined, especially those present, the meetings have been more engaging and productive, and Melissa agreed.

- viii. Jamien also asked how we as a Board stay motivated and don't feel compelled to also step down. Wanda suggested the Board members reflect on why they joined the Board and keep that in mind, particularly the interest in advocating for youth of Erie County. She noted we may be frustrated, but change happens when we work together in the interest of the youth and stay positive and focused on that.
  - 1. LaShawn suggested the Board stay in touch via email to maintain communication. Wanda said it was okay to keep her off the emails and then discuss things together at the meeting.
- ix. Maria shared feeling a little unsure where to go from here; having been on the board just under a year, she does not really know what the Committees do or what the Board can do aside from reviewing proposals. Wanda offered to gather more information from Sue and share findings at the next meeting.
  - 1. John echoed these concerns as Melissa seemed to be the seasoned member leading us. As he does not live in Buffalo anymore, he does not know what concerns to bring. He isn't sure who we bring on to the Board that can be the Chair or that may know how things should or can go.
